


#### Total Membership in All Health Connector Programs

As of 1/2/2023 there are 259,008 members enrolled in Health Connector programs, including 214, 102 non-group health plan enrollees















### APTC-only Membership by Metallic Tier and Standardization January 2023





#### Unsubsidized Membership Monthly Additions and Terminations




### Unsubsidized Membership by Carrier









Non-Group Membership by Health and Dental Enrollment









# Health Connector for Business Health Membership by Carrier January 2023 Tufts Health Direct – 5,269 (45%)




Health Connector for Business Health Membership by Choice Model January 2023










### Health Connector for Business Dental Group Monthly Additions and Terminations
